INVESTMENT PHILOSOPHY & PROCESS

- The strategy seeks to generate virtually all of its excess return from security selection: bottom-up sub-sector rotation within the corporate and mortgage/structured product sectors, and fundamental research-based security selection in all sectors.
- Top-down decisions such as duration and yield curve are tightly constrained to benchmark. Sector allocations are also constrained, but modest deviations may be a source of excess return.
- We manage the Strategy as a lower-risk, lower tracking error alternative to other Core Strategies.
- Our philosophy is to construct highly diversified, benchmark-focused portfolios and implement risk exposures in areas where we have demonstrable expertise, such as research-based subsector and security selection, while constraining top-down exposures such as duration, yield curve, and sector allocation.
- We believe that intensive, bottom-up fundamental credit research on both industries and securities, coupled with experienced relative value analysis, can effectively identify undervalued yet creditworthy subsectors and securities regardless of environment or market cycle.
- We regard these as high information ratio, lower risk activities that can consistently generate alpha across markets.

Develop benchmark-focused portfolio strategy

- U.S. Government sector—use quantitative models to replicate the index with the most attractively valued securities.
- Mortgage sector—use quantitative models to identify the combination of securities within Index with the goal of optimizing expected return.
- Corporate and structured product sectors—based extensive fundamental research and relative value analysis.

Constrain duration, yield curve, sector and quality

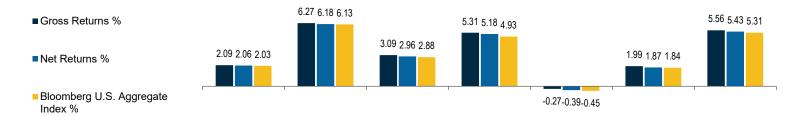
- The goal of this approach is to provide index-like risk while permitting us to add excess return in select areas.
- We then look to add alpha through subsector and security selection:
 - Within U.S. Government and mortgage sectors we use proprietary tools to find attractive fundamental relative value opportunities.
 - Within Corporates and structured products we identify a small subset of subsectors and individual securities that we believe offer value.

Monitor Portfolio vs. Benchmark on Daily Basis

- Each portfolio's risk characteristics and positioning are monitored daily by both the Senior Portfolio Managers and a separate risk manager via on-line reports
- A proprietary system developed by our internal Investment Risk Management and Quantitative Research Group aggregates all risk exposures daily, for each portfolio and its benchmark.

INVESTMENT COMMENTARY

Markets

The bull market for fixed income continued through Q. U.S. Treasury yields declined and the curve steepened over the quarter as the U.S. Fed cut interest rates by 25 bps at its September meeting. Meanwhile, credit products generally posted strong total returns, with spreads for U.S. investment grade corporates continuing to tighten amid persistently strong technicals and stable fundamentals. Meanwhile, MBS posted positive excess returns versus U.S. Treasuries in Q3, with the majority of that performance coming from the longer duration, 30-year sector, while the 20-year and 15-year sectors lagged.

Developed market rate complexes received some direction in Q3 as the Fed resumed what could become a prolonged, and possibly deep, rate-cutting cycle. While the impact of higher tariffs and changing trade flows is beginning to show in price and production data, consumer spending, labor markets, and corporate performance remain mostly robust, providing a critical buffer. As a result, our base case remains one of "muddle through," that is moderate growth and inflation, even amid heightened policy uncertainty.

This environment continues to challenge investors and analysts alike. Similarly, it continues to create distortions in the interest rate, sector, issuer, and currency realms, resulting in risks, but also continued opportunities for adding value through active management across the public and private asset spectrum. The 2022 selloff left yields at respectable levels—which largely remain intact—with an unusual net result: a potentially long-lived bull market primarily driven by the accretion of income, rather than a short bull market fueled by a quick drop in yields. The trend of compressing credit spreads should generally continue, albeit more modestly given the tight spread levels.

Portfolio

Overall sector allocation and security selection both contributed to performance over the period. Within sector allocation, overweights to the MBS and non-agency CMBS AAA sectors, along with an underweight to U.S. investment grade corporates, were the largest contributors.

Within security selection, selection in the U.S. investment grade corporate and non-agency CMBS AAA sectors contributed the most. This was partially offset by selection in MBS, which detracted. During the quarter, the yield curve and duration positioning, in aggregate, modestly detracted. From a market perspective, having less risk in the portfolio, on average, than the relevant benchmark over the period had a modestly negative impact on performance.
